## OPEN CALLS

You must come in workout attire and appropriate footwear to be considered. You will be tested on your physical ability in areas such as strength, speed, balance and agility. We recommend bringing a workout towel and water with you to the open call.

- Please bring a non-returnable photo of yourself with a completed **Application** to the open call.
- Open call lines will begin forming 2 hours before the start time. Please do not line up prior to that time.
- Time is limited and there is no guarantee that everyone will be seen – so please arrive early.

## VIDEOTAPE

**If you are unable to attend an open call, please submit a videotape. Follow the instructions below to find out how.**

Applications **MUST** be clearly written and must be accompanied by a video (subject to the exception set forth below) that meets these requirements:

LENGTH:           MAXIMUM OF FIVE MINUTES.

FORMAT:           VHS/DVD, or mini-DV

CONTENT:          Start with your name, hometown, and occupation. There is no "right" or "wrong" thing to say on a tape, we just want to get to know you (**BUT MOST IMPORTANTLY HAVE SOMEONE ELSE TAPE YOU**). Take us on a tour of your life; show us what's important to you. What sets you apart from the other participants? **DON'T JUST TELL US, SHOW US!**

Briefly take us through your job, but most importantly we want to see you in **ACTION**. We want to see **YOUR HOBBIES** (i.e., If you ride horses or motorbikes, let's see you in action.) Show us what makes you-**YOU!** We want to see the town you live in. **HAVE FUN and LET'S SEE YOUR PERSONALITY!!!**

The video must be original, truthful, unpublished, created solely by the submitting applicant, must not have been submitted in any other competition, and must not infringe upon any rights of any third party, including, but not limited to, copyright, trademark, and rights of privacy and publicity. You should not attempt anything dangerous or harm anyone or any animals in the making of this video. We will not consider any submission that we deem unsafe. In addition, your family must be the owner or legal lessee of the home or property depicted in the video, if any. The video must not include any music or singing.

The video will become the property of the Producers and will not be returned to you, whether or not you are selected as a participant.

Applications will be considered only if they are complete. Completed applications consist of the following:

- 1) Completed and signed Application Form
- 2) Completed and signed Certification of Veracity
- 3) Completed and signed Waiver and Release
- 4) One separate photo of yourself
- 5) A recent resume
- 6) Your up to five-minute videotape clearly labeled with your name, address, and phone number.

Please do not include anything except the five items listed above.

**NOTE: YOU ONLY NEED TO MAKE A VIDEO PROFILE IN CONNECTION WITH YOUR APPLICATION IF YOU CAN'T MAKE IT TO ONE OF THE OPEN CASTING CALLS.**

**IV. Eligibility Requirements and Releases:**

64) You must be at least 18 years of age.

65) You must be a legal US resident of the 50 United States and/or Washington D.C.

66) You must not be a candidate for public office and must agree not to become one until after one (1) year after the initial broadcast of the episodes of the Program in which you appear, if selected as a participant.

67) You may not participate in the Program if your participation would create impropriety or the appearance of impropriety. In making this determination, Am Glad Productions (the “Producer”) and NBC Universal, Inc. (“NBCU”) will consider whether you or any member of your immediate family or anyone living in your household is or has been within the last two (2) years an employee, officer, director or agent of any of the following:

- (a) NBCU or any television production company, network, station or distributor owned and operated by NBCU;
- (b) Am Glad Productions (“Producer”), Reveille, LLC, Ben Silverman Productions, LLC dba Reveille 2, Reveille Independent, LLC or any of their respective parent, subsidiary or affiliated companies, or any other person or entity any person or entity involved in the development, production, distribution or other exploitation of the reality-based program currently entitled “American Gladiators” (the “Program”) or any variation thereof;
- (c) Any sponsor of the Program or its advertising agency; or
- (d) Any person or entity supplying prizes or other services to the Program.

In addition, Producer and NBCU reserve the right to render ineligible any person whom any of them determines, in its sole discretion, is sufficiently connected with the production, administration, judging, or distribution of the Program, such that his or her participation in the Program could create the appearance of impropriety. Such decisions shall be final and are not subject to challenge or appeal.

- 68) If selected as a participant you must execute waivers and release agreements required by Producer and NBCU or any of their licensees, successors or assigns.
- 69) You will need to be available to the production and for any promotional appearances required by Producers or NBCU and you will need to be willing to travel to one or more locations designated by Producers in their sole discretion.
- 70) Any person who has ever been a participant on the Program is not eligible to participate again; provided, however, Producers reserve the right to invite back any participant(s) for special episodes of the Program.
- 71) Any offer to become a participant is conditioned upon your submission to physical examinations to be conducted in Los Angeles, CA, by medical professionals selected by and paid for by the Producers and the certification of the medical professionals that you meet all physical requirements. You must be willing to submit medical information to the production, and you must be willing to submit to a medical examination and background check.

72) Participant Selection:

- (a) Applicants applying to be participants must complete and sign the “American Gladiators” Application and attend one (1) or more audition/interview sessions. Producers, in their sole discretion, will determine who among the people interviewed will be placed into the pool of eligible potential participants (“Audition Player Pool”). Producers, in their sole discretion, shall select people from the Audition Player Pool to become finalists for episodes of the Program (each, a “Finalist”).

(b) Selection of Finalists and participants shall be made by Producers based on such criteria as Producers shall determine in their sole discretion, which may be subjective. Producers are not obligated to select anyone, even if someone meets all eligibility requirements and all criteria for selection. Producers' decisions regarding the selection of Finalists and participants are final and not subject to challenge or appeal. Producers are not obligated to have any applicant appear on the Program and Producers shall have the right at all times and in their sole discretion to remove or replace any participant for any reason or no reason. Even if a participant participates in the Program or any part thereof, Producers and NBCU are not obligated to broadcast or otherwise use or exploit the Program, participant's participation therein or any part thereof.

(c) All Finalists must sign and return waivers and release agreements required by Producers and NBCU and/or any of their licensees, successors and assigns.
