- 2) You must be a legal US resident.

(“Producer”) and NBC Universal, Inc. (“NBCU”) will consider whether you or any member of your immediate family or anyone living in your household is or has been within the last two (2) years an employee, officer, director or agent of any of the following:
 - (a) NBCU or any television production company, network, station or distributor owned and operated by NBCU;
 - (b) Producer, or any other person or entity any person or entity involved in the development, production, distribution or other exploitation of the reality-based program currently entitled “Great American Road Trip” (the “Program”) or any variation thereof;
 - (c) Any sponsor of the Program or its advertising agency; or
 - (d) Any person or entity supplying prizes or other services to the Program.

In addition, Producer and NBCU reserve the right to render ineligible any person whom any of them determines, in its sole discretion, is sufficiently connected with the production, administration, judging, or distribution of the Program, such that his or her participation in the Program could create the appearance of impropriety.

- 5) If selected as a participant you must execute waivers and release agreements required by Producer and NBCU or any of their licensees, successors or assigns.
- 6) You will need to be available to the production by May 4, 2009 through June 30, 2009 and be willing to travel to various locations as part of production.
- 7) Any offer to become a participant is conditioned upon your submission to physical and psychological examinations to be conducted in Los Angeles, CA, by medical professionals selected by and paid for by the Producers and the certification of the medical professionals that you meet all physical and psychological requirements. You must be willing to submit medical information to the production, and you must be willing to submit to a medical examination, psychological examination, and background check.

EACH MEMBER OF YOUR FAMILY MUST COMPLETE AND RETURN THE APPEARANCE AND ARBITRATION RELEASE FORM ALONG WITH YOUR APPLICATION AND DVD IN ORDER FOR YOUR APPLICATION AND DVD TO BE REVIEWED.

RELEASE FORM

1. I hereby grant to BBC Worldwide Americas, Inc. NBC Universal, Inc. and their respective parents, subsidiaries and affiliated companies, successors, licensees and assigns, and their respective officers, directors, employees and agents (collectively "Producer") the right to take motion and still pictures of me and record my voice and any sounds made by me, my actions, likeness, name and appearance, and to obtain other information about me and/or contained in, derived from or obtained in connection with my application to be a participant in the Program (collectively, the "Footage and Materials"). Producer shall have the right, but not the obligation, to use the Footage and Materials in whole or in part, as edited, altered, or modified by Producer, and in any manner in connection with the development, production, distribution and/or exploitation of the television program currently entitled "GREAT AMERICAN ROAD TRIP" (the "Program"), and/or any other production, and in the advertisements, publicity, marketing and promotions for any such production and for the television network and stations that broadcast any such production (the "Advertisements"), throughout the universe at any time, in perpetuity, in any and all media now known and hereafter devised, without any compensation to me whatsoever. I agree that Producer exclusively owns all right, title and interest (including, without limitation, all copyrights) in and to any and all recordings made by Producer and in and to any and all video that I have provided in connection with my application and any other materials that I have provided or may provide in connection with my application or the Program (collectively "Application Materials"), including without limitation, the right to edit, alter or modify the Application Materials and to use all or part of the Application Materials in any and all media now known or hereafter devised worldwide, in perpetuity, in connection with my application or the Program, or in Advertisements. I represent and warrant that I own all rights to such music, and I grant Producer the right to record, reproduce and publicly perform any such music in and in connection with the Program or any other work.

2. I hereby grant to Producer the right, but not the obligation, to incorporate the Video Footage contained within the DVD Submission ("Property") in any manner Producer sees fit in and in connection with the Program and to use and authorize others to use the Property in the Program and in connection with the distribution, sale, licensing, marketing, advertising, promotion, exhibition and other exploitation of, and other materials relating to the Program or any other work in all markets and media (whether now known or hereafter developed), throughout the universe, in perpetuity.

3. I hereby consent to the recording, use and reuse by Producer of the voices, actions, likenesses, names, appearances, performances, biographical material, and any information contained in the Property (collectively, "Personal Elements") as edited, altered, fictionalized or modified by Producer, in any and all media now known or hereafter devised, worldwide in perpetuity, in or in connection with nbc.com or in any other website or production. I agree Producer may use all or any part of my Personal Elements, and may make any changes that Producer may deem necessary, including altering, fictionalizing or modifying them regardless of whether or not I am recognizable.

4. I warrant and represent that (i) the Property is an original work by me and I have not copied or used other works (such as dialogue from plays or recordings of musical works) without permission or right to do so; and (ii) I have the sole right and authority to grant all rights granted herein and Producer's use of the Property as permitted herein

will not infringe on the rights of any third-party, including, without limitation, copyright and trademark, defamation, privacy and publicity, false light, idea misrepresentation or any contractual rights.. Owner will indemnify and hold Producer its parents, subsidiaries and affiliated companies, successors, licensees and assigns, and their respective officers, directors, employees and agents, harmless from and against any and all claims, damages, liabilities, costs and expenses arising out of any breach of the foregoing representations and warranties.

5. I have not given or agreed to give anything of value to anyone so I could be in the Program or the Advertisements. I know that Producer does not permit it and that it would be a Federal offense not to tell Producer prior to broadcast if I had.

6. I understand I will not be paid; and I hereby waive any right to any compensation for appearing in the Program, in the Advertisements, and in the Footage and Materials, for giving Producer the rights listed in this Agreement, and for Producer's exercise of any and all of the rights listed in this Agreement. I acknowledge that I am a volunteer and that I shall not be deemed to be an employee of Producer or be entitled to the benefits provided by Producer to its employees.

I hereby authorize Producer and any person or entity designated by Producer to investigate, access and collect information about me, about any of the statements made by me in my application, this Agreement, any supporting documents and any other documents that I have signed or provided or do sign or provide in connection with my application to be selected as a participant in the Program, or any other written or oral statements I make in connection therewith. I irrevocably authorize Producer and any person or entity designated by Producer to secure information about me and my experiences from my current and former employers, associates, friends, family members, educational institutions, government agencies, credit reporting agencies, and any references I have provided, and I irrevocably authorize such parties to provide information concerning me. I hereby unconditionally and irrevocably release and forever discharge Producer, the persons or entities designated by Producer, and all such parties and persons from any and all liabilities arising out of or in connection with any such investigation. I specifically authorize investigation of my employment records, medical records, and government records, including but not limited to my motor vehicle records, criminal records and credit and/or consumer report(s). I acknowledge and agree that any such information obtained by Producer or by any person or entity designated by Producer pursuant to this paragraph or otherwise may be used for purposes of selecting participants in the Program, and may be described or otherwise related in and in connection with the Program.

I hereby authorize Producer and any person or entity designated by Producer to conduct psychological and physical examinations of me as required by Producer. I further authorize the individuals conducting such examinations of me to disclose to Producer and their representatives all information about me obtained in connection with such examinations, and authorize Producer to utilize such information in selecting participants for the Program.

7. RELEASE, AGREEMENT NOT TO SUE AND INDEMNITY. To the maximum extent permitted by law, I agree that I will never sue Producer, NBC Universal, Inc., and any station or network that exhibits the Program, and each of their respective parents, subsidiaries and affiliated companies, successors, licensees and assigns, and their respective officers, directors, employees and agents (the "Released Parties") or anyone because I do not like the manner in which Producer took or used the Footage and Materials or Application Materials or for any cause of action based on any of the Released Claims (as defined below). To the maximum extent permitted by law, I, for myself and on behalf of my heirs, executors, agents, successors or assigns, hereby release, hold harmless, and forever discharge the Released Parties, from any and all claims, actions, damages, losses, liabilities, costs, expenses, injuries or causes of action whatsoever that in any way are caused by, arise out of or result from this Agreement, my appearance in the Footage and Materials, the Application Materials, the Program, or in the Advertisements, the creation of the Footage and Materials, or the broadcast or other exhibition of the Program, the Footage and Materials, the Application Materials or the Advertisements, on any legal theory whatsoever (including, but not limited to, personal injury, rights of privacy and publicity, defamation, or false light), regardless of whether caused by the negligence or willful misconduct of the Released Parties (collectively, the "Released Claims"). I will defend, indemnify and hold the Released Parties harmless from any and all such claims, actions, damages, losses, liabilities, costs, expenses, injuries or causes of action, as well as all those that in any way are caused by, arise out of or result from any breach or alleged breach by me of any of the representations or warranties made by me in this Agreement.

8. To the maximum extent permitted by law, I waive any and all rights I may have under Section 1542 of the Civil Code of California, and every like provision in any foreign jurisdiction. Section 1542 provides as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR.

9. MEDIATION & ARBITRATION. The parties agree that if any controversy or claim arising out of or relating to this Agreement cannot be settled through direct discussions, they shall endeavor first to settle the controversy or claim by a mediation administered by JAMS under its applicable rules. **IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, THE PARTIES AGREE THAT IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (THE "JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE AN ARBITRATOR EXPERIENCED IN THE ENTERTAINMENT INDUSTRY AND LICENSED TO PRACTICE LAW IN CALIFORNIA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF LOS ANGELES. THE PARTIES AGREE THAT THE REMEDY FOR ANY CLAIM BROUGHT PURSUANT TO THIS AGREEMENT SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE OR EXEMPLARY DAMAGES OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.**

10. MISCELLANEOUS. I agree that Producer may license, assign, and otherwise transfer this Agreement and all rights granted by me to Producer under this Agreement to any person or entity. This is the complete and binding agreement between Producer and me, and it supersedes all prior understandings and communications, both oral and written, with respect to its subject matter. The illegality, invalidity or unenforceability of any provision of this Agreement shall in no way affect the validity or enforceability of any of the remainder of this Agreement, which shall be enforced to the maximum extent permitted by law. This Agreement cannot be terminated, rescinded or amended, except by a written agreement signed by both Producer and me. This Agreement shall be interpreted under the internal, substantive laws of the State of California without regard to the conflicts of law provisions thereof.

I UNDERSTAND THAT I AM GIVING UP CERTAIN LEGAL RIGHTS UNDER THIS AGREEMENT, INCLUDING, WITHOUT LIMITATION, MY RIGHT TO FILE A LAWSUIT IN COURT WITH RESPECT TO ANY CLAIM ARISING IN CONNECTION WITH THIS AGREEMENT.
