Applications **MUST** be clearly written and must be accompanied by a video (subject to the open call exception set forth below) that meets these requirements:

LENGTH: MAXIMUM OF FIVE MINUTES.

FORMAT: VHS/DVD, or miniDV

CONTENT: We recommend that someone else record you and your son/daughter, don't just walk around behind the camera. Start with your name, hometown, and occupation (one by one of course), as well as the name and grade level of your son/daughter. There is no "right" or "wrong" thing to say on a tape, we just want to get to know everybody. Take us on a tour of your lives; show us what's important to everyone. What sets you apart from other people? **DON'T JUST TELL US, SHOW US!!!**

Briefly take us through your job, but most importantly we want to see everyone in **ACTION** and why you should be picked for the show. We want to see **EVERYONE'S HOBBIES** (I.e. you ride horses, let's see you in action, if you live on a ranch let's see you out there!) Show us what makes you-YOU! We want to see the town you live in. **HAVE FUN and LET'S SEE YOUR PERSONALITIES!!!**

The video must be original, truthful, unpublished, created solely by the submitting applicant, must not have been submitted in any other competition, and must not infringe upon any rights of any third party, including, but not limited to, copyright, trademark, and rights of privacy and publicity. In addition, your family must be the owner or legal lessee of the home or property depicted in the video, if any. The video must not include any music or singing.

DEADLINE: Completed applications and videotapes must be received by December 7, 2007 at 12:00 PM ET to be considered. **Remember, the earlier the better.**

The video will become the property of Better Productions, Inc. and will not be returned to you, whether or not you are selected as a Contestant.

Applications will be considered only if they are complete. Completed applications consist of the following:

- 1) Completed and signed Application Form and Certification of Veracity for Dad
- 2) Completed and signed Application Form and Certification of Veracity for Child, with signed Parental Consent

- 3) One photo of you with your son/daughter
- 4) A recent resume for Dad
- 5) Your up to five-minute videotape clearly labeled with your names, address, and phone number.

Please do not include anything except the five items listed above. **NOTE: YOU ONLY NEED TO MAKE A VIDEO PROFILE IN CONNECTION WITH YOUR APPLICATION IF YOU CAN'T MAKE IT TO ONE OF THE OPEN CASTING CALLS DURING NOVEMBER OF 2007 IN LOS ANGELES.**

EXTENDED APPLICATION INSTRUCTIONS:

2. You and your child must fill out each entire application. Do not leave any question unanswered. Failure to answer any question may be grounds for not considering your applications. To be considered for this show, you must fill out these applications honestly, accurately, completely, and to the best of your ability. If any question is not applicable to you, write N/A in the space provided, or if no space is provided, next to the question. Failure to do so may result in your elimination from consideration or from the show, as well as the forfeiture of any prizes or other things you may have been awarded, whether or not you have already received them. Applications that are incomplete, illegible, arrive with postage due or corrupted are void and will not be accepted.
3. Please write only on the printed side of the paper, but feel free to attach additional sheets if necessary.



Eligibility Requirements:

1. Each “dad” contestant (“Contestant”) for the television program currently entitled “My Dad Is Better Than Your Dad” (the “Program”) must be 18 years of age or older and a legal resident of the 50 United States and/or Washington D.C.
2. You must not be a candidate for public office and must agree not to become one until after one (1) year after the initial broadcast of the episodes of the Program in which you appear, if selected as a Contestant.
3. You may not participate in the Program if your participation would create impropriety or the appearance of impropriety. In making this determination, Better Productions, Inc. (**Better Productions, Inc. and its licensees, successors, and assigns, and each of their respective officers, directors, shareholders, employees, agents, and representatives shall be referred to herein as “Producer”**) and NBC Universal, Inc. (“Network”) will consider whether you or any member of your immediate family or anyone living in your household is or has been within the last two (2) years an employee, officer, director or agent of any of the following:
 - (a) Network or any television production company, network, station or distributor owned and operated by Network;
 - (b) Producer, Ben Silverman Productions, LLC dba Reveille 2, Reveille Independent, LLC, Reveille, LLC, or any other person or entity involved in the development, production, distribution or other exploitation of the Program or any variation thereof;
 - (c) Any sponsor of the Program or its advertising agency; or
 - (d) Any person or entity supplying prizes or other services to the Program.

In addition, Producer and Network reserve the right to render ineligible any person whom Producer or Network determines, in their sole discretion, is sufficiently connected with the production, administration, casting, judging, or distribution of the Program, such that his or her participation in the Program could create the appearance of impropriety. Such decisions shall be final and are not subject to challenge or appeal.

4. Any person who has ever been a Contestant on the Program is not eligible to participate again; provided, however, Producer reserves the right to invite back any Contestant for special episodes of the Program.
5. If selected as a Contestant, you will need to be available for at least one (1) full day for the production of the Program, as well as for any promotional appearances required by Producer or Network, and you must be willing to travel to one or more locations designated by Producer and/or Network in their sole discretion.

6. Any offer to become a Contestant is conditioned upon your submission to, if requested by Producer, physical examinations by medical professionals selected by and paid for by Producer, and the certification by such medical professionals that you meet all of the physical requirements for participation in the Program. In addition, you must be willing to provide any requested medical information to Producer and/or Network, and you must be willing to submit to any psychological examination(s) and any background check(s), if and as requested by Producer.

7. Contestant Selection:

(a) Applicants applying to be Contestants must complete and sign the “My Dad Is Better Than Your Dad” Application (“Application”) and attend one (1) or more audition/interview sessions. Producer, in its sole discretion, will determine who among the people interviewed will be placed into the pool of eligible potential Contestants (“Audition Player Pool”). Producer, in its sole discretion, shall select people from the Audition Player Pool to become finalists to participate as Contestants on episodes of the Program (each, a “Finalist”).

(b) Selection of Finalists and Contestants shall be made by Producer based on such criteria as Producer shall determine in its sole discretion, which may be subjective. Producer is not obligated to select anyone as a Finalist and/or Contestant, even if someone meets all eligibility requirements and all criteria for selection. Producer’s decisions regarding the selection of Finalists and Contestants are final and not subject to challenge or appeal. Producer is not obligated to have any Contestant appear on the Program and Producer shall have the right at all times and in its sole discretion to remove or replace any Contestant for any reason or no reason.

(c) All Finalists must sign and return waivers, releases, and authorizations required by Producer and Network and/or any of their licensees, successors and assigns.

(d) Any Finalist who refuses to sign any of the requested waivers, releases or authorizations shall be ineligible to participate as a Contestant on the Program and/or shall be subject to disqualification from the Program in Producer’s sole discretion.

8. You hereby give the following acknowledgements, consents and releases:

(a) By signing below and submitting the Application, you hereby acknowledge that: (i) you have read and you meet and agree to be bound by the eligibility requirements set forth herein; (ii) you have completed the Application honestly and accurately; (iii) if any of the information in the Application is found to be false or incomplete, it will be grounds for dismissal from the Contestant selection process and/or from the contest and/or from the Program if selected as a Finalist and/or Contestant; (iv) even if you meet the eligibility requirements herein, Producer has no obligation to interview you and/or select you as a Contestant; (v) you agree to keep strictly confidential all information about the Program that you acquire during the Contestant selection process and/or during your participation in the Program (if applicable); (vi) your voice, actions, and likeness will be recorded as a part of the Contestant selection process, and you understand that Producer may, but is in no way obligated to, actually use such recordings within the Program or in any other manner; (vii) even if a Contestant participates in the Program or any part thereof, Producer and Network are not obligated to produce the Program, conduct the contest, or broadcast or otherwise use or exploit the Program, Contestant’s participation therein or any part thereof (even if the Program is produced and the contest is

conducted); and (viii) Producer has no obligation to return any Materials (as defined hereinbelow) submitted by you as part of the Contestant selection process whether or not you are selected as a Contestant, and Producer may, but is in no way obligated to, use any such Materials in the Program or in any other manner (as further discussed hereinbelow).

(b) By signing below and submitting the Application, you hereby consent to the recording, use and reuse by Producer and Network, and each of their respective licensees, successors, assignees, parents, related companies, subsidiaries (whether or not wholly-owned), affiliates, divisions, and the past, present and future officers, directors, agents, representatives, employees, successors and assigns of each of the foregoing, jointly and individually (hereinafter collectively referred to as "Releasees"), of your name, voice, actions, likeness (actual or simulated), sobriquet, appearance, biological and biographical information, and any information contained in, derived from or obtained in connection with the Application (collectively, "Likeness"), as well as any recordings or photographs of you taken during the Contestant selection process and any materials, including, without limitation, any photographs or videos, ("Materials") submitted by you (or that you may submit) in connection with the Application, the Contestant selection process, and the Program, as edited, altered, or modified by Producer or by any of the other Releasees, in any and all media, whether now known or hereafter devised, throughout the universe, in perpetuity, including, without limitation, in and in connection with the development, production, distribution and/or exploitation of the Program and/or any other production, and the advertising, promotion, publicity, marketing, and merchandising thereof, without any compensation whatsoever. You agree that Releasees may use all or any part of your Likeness and/or the Materials, including in any and all promotions, marketing, advertising or publicity, and may alter or modify such regardless of whether or not you are recognizable. Further, by signing below and submitting the Application, you warrant and represent that everyone appearing in any video submitted by you in connection with the Application (each, a "Video Submission") and anyone who may have shot such Video Submission(s) agrees that such Video Submission(s) may be used, as edited, altered, or modified by Producer or by any of the other Releasees, in any and all media, whether now known or hereafter devised, throughout the universe, in perpetuity, including, without limitation, in and in connection with the development, production, distribution and/or exploitation of the Program and/or any other production, and the advertising, promotion, publicity, marketing, and merchandising thereof, without any compensation whatsoever. You further warrant and represent that you have all rights, licenses, permissions and consents necessary to submit the video and to grant all of the rights that you have granted to Producer herein, and that you have obtained written permission when filming any part of the Video Submission(s) on private property not owned or controlled by you, where such permission is required. You further agree that Releasees exclusively own all right, title, and interest (including, without limitation, all copyrights and extensions and renewals thereof) in and to any such recordings and any other Materials. Without in any way limiting the foregoing, if you perform or include any music (other than music supplied to you by Producer) in connection with your application or the Program, you represent and warrant that you own all rights to such music, and you grant Producer the right to record, reproduce and publicly perform any such music in and in connection with the Program or any other work. Without in any way limiting the waivers and releases set forth herein, you waive any claims to royalties of any kind, whether accruing now or in the future, from Producer and Network for the use of any such music, including, without limitation, any applicable copyright, public performance, mechanical and synchronization royalties. You grant the rights hereunder whether or not you are selected to participate as a Contestant in the Program. You hereby release Releasees from any and all liability arising out of their recording or use of your Likeness and/or the Materials and any and all claims, actions, damages, liabilities, losses, costs and expenses (including, without limitation,

attorneys' fees) in any way arising out of or resulting from the recording or use of your Likeness and/or the Materials. You agree not to make any claim against any of the Releasees as a result of the recording and/or use of your Likeness and/or the Materials (including, without limitation, any claim that such use defames you or invades any right of privacy and/or publicity). You understand that you will not be paid any money for giving Releasees these rights or for signing the Application.

(c) You agree to take, at Producer's expense, any further action, in writing (including, without limitation, execution of affidavits and/or other documents), requested by Producer to effect, perfect or confirm Producer's and Network's rights in the Materials and your Likeness, including, without limitation, the rights to use, modify, reproduce, publish, perform, display, distribute, make derivative works of and otherwise commercially and non-commercially exploit the Materials and your Likeness in perpetuity and throughout the universe, in any manner or medium, whether now existing or hereafter developed, without separate compensation to you or any other person or entity.

(d) You understand that the Contestant selection process will involve subjective decisions made by certain individuals selected by Producer and/or Network in their sole discretion. You understand and agree that all Contestant selection and elimination decisions shall be final and binding on you in all respects, and shall not be subject to challenge or appeal.
