QUESTIONNAIRE RELEASE AGREEMENT

I understand that the above release is a material inducement for you to proceed with the Series, and that NBC and Producer and the other Released Parties may rely on this release in proceeding with the Series. I further understand and agree that all rights under Section 1542 of the California Civil Code and any similar law of any State or territory of the United States are hereby expressly waived by me. Said section reads as follows:

"1542. Certain claims not affected by general release. A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

I understand that neither I nor anyone else will be paid for my granting the above rights, or for my signing this agreement. My participation in the casting process for the Series, and in the Series itself (if any), do not constitute a performance and will not entitle me to wages, salary, or other compensation. I agree and acknowledge that no one (including Producer or NBC) has asked me for any money or other consideration to be considered for participation in the Series..

I authorize NBC and Producer to investigate, access and collect information about me, about any of the statements made by me in my questionnaire, any supporting documents and any other document that I have signed or do sign in connection with my application to be selected as a participant in the Series, or any other written or oral statements I make in connection therewith, and hereby waive all rights of privacy or confidentiality that I might otherwise have in such information. HOW TO MAKE A VIDEO SUBMISSION

Remember: Accepted video formats include: DVD, MINI DV, VHS, MINI DVD (that has been finalized from your camera). Please view video before shipping to us. As a back-up plan make yourself a copy in the event that your tape gets lost. No tapes will be returned to you.

Dear Nominee:

Please know this tape could be used on television so make sure appearances are fit for TV! The colors white and red are not television-friendly colors, nor are tight check patterns or stripes. Logos on t-shirts should also be avoided. You should dress casual as if you were going out for a family dinner or nice lunch. Ladies, please take the time to put on light make up and look nice. This is the first impression you are making on producers. For example, try not to wear sweat pants unless that's all you have.

SHOT LIST:

You should know that the casting department will edit your tape, so don't get nervous if you mess up, just keep talking, we can cut around it. IT IS OUR JOB TO MAKE YOU LOOK YOUR BEST!

Just give us the following elements:

1. **INTRODUCTION OF YOURSELF**
2. **DISCUSSING THE EVENT/S or CIRCUMSTANCES THAT ARE AFFECTING YOUR LIFE**
3. **VIDEO DIARY – DOCUMENTING DAILY LIFE CHALLENGES**

IF POSSIBLE, SHOW HOW YOUR LIFE IS AFFECTED.

FOR EXAMPLE: If you have a panic attack or suffer from insomnia try capturing it on video.

BASIC CAMERA TIPS

1. If you are the person operating the camera during the tour, please don't talk. Your job is to pay attention to holding the camera steady, lighting, sound, etc.
2. Camera angles are important. Please make sure there isn't a large amount of space between the tops of heads and the top of the screen (we call this "head space").
3. During an interview, if you are asking questions to prompt the person talking on camera, don't talk over them and ask them to repeat the question in the answer. If you are not on camera, your voice will be cut out.
4. If someone is telling an emotional story, the camera should be very close to the subject so we can see and hear them. Just that person's face should be in the screen. No one else.
5. DON'T use the zoom feature.
6. Keep your movements slow and steady, the lens can't move as fast as your eye.
7. Use auto focus and pay attention to how much light is in the room.
8. If it is daytime, do not have any one stand in front of a window talking.
9. Please turn off TV and Radio in the background and make sure that people who aren't on camera are not talking. That goes for noisy pets, no matter how cute they may be!
10. If you don't have a tripod, consider setting the camera on a table or something that the camera can sit on. Some have used phone books piled up on a table to get good height.
11. Please don't chew gum.
12. Make sure the Time/ Date stamp is off so it doesn't show up on the video.
13. If you are being interviewed, please don't sit in a rocking and / or swivel chair. Also, be mindful of fidgeting while you are talking to camera.
14. Do not include anything in the video that would be considered pornographic, obscene, defamatory, or in violation of any local, state, or federal laws or other applicable regulations.
