- (b) HSN General Partner, LLC, the Home Shopping Network or affiliated or subsidiary companies (collectively referred to herein as “HSN”);
- (b) Any television network, station or channel, cable network, or satellite network that may air the Program;
- (c) Any person or entity involved in the development, production, distribution or other exploitation of the Program or any version or variation thereof;
- (d) Any sponsor of the Program or its advertising agency; or
- (e) Any person or entity supplying services or prizes to the Program.

In addition, Realand Productions, LLC, USA, and HSN reserve the right to render ineligible any person who any of them determines, in its sole discretion, is sufficiently connected with the production, administration, judging, or distribution of this Program such that his or her participation in the Program could create the appearance of impropriety.
