

RT To Win The Voice Autographed Poster

Official Rules

March 17, 2015 – April 8, 2015

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. RT to Win The Voice Autographed Poster (“Sweepstakes”) will begin on March 17, 2015 at 4:00pm PT and end on April 8, 2015 at 11:59pm PT (“Sweepstakes Period”). All times in the Sweepstakes refer to Pacific Time (“PT”). Odds of winning depend upon the number of eligible Entries received. Sweepstakes is subject to all applicable federal, state and local laws.

ELIGIBILITY: Open only to permanent, legal United States (“U.S.”) residents who are physically residing in one (1) of the fifty (50) United States or District of Columbia (excluding Puerto Rico, Guam, the U.S. Virgin Islands and other United States territories), and who are eighteen (18) years of age or older and of the age of majority in their state of residence as of the start of the Sweepstakes Period. Officers, directors, and employees of Sweepstakes Entities (as defined below), members of these persons’ immediate families (spouses and/or parents, children, and siblings, and each of their respective spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Sweepstakes. Each Drawing will consist of (i) an entry period (a “Entry Period”) that will begin at a specified time (each a “Entry Period Start Time”) as detailed in the chart below and will end at a specified time (each a “Entry Period End Time”) as detailed in the chart below and (ii) a random Drawing conducted on the drawing date (“Drawing Date”) specified in the chart below from among all eligible Entries (defined below) received during such Entry Period. Entries must be received before the end of the Entry Period to be eligible for the corresponding Drawing. On There will be a total of thirteen (13) Winners (defined below) selected throughout the Sweepstakes Period.

To enter the Sweepstakes, during the Sweepstakes Period go to www.twitter.com, (“Twitter Site”) and (1) if you already have a Twitter account, log on using your Twitter user name and password, then become a follower of @NBCTheVoice by searching for @NBCTheVoice, clicking on the The Voice icon and then clicking the "Follow" button or (2) if you do not already have a Twitter account, create a free Twitter account according to the instructions on the Twitter Site and follow @NBCTheVoice as indicated in (1) above. Please note that you must agree to comply with the Twitter Terms of Use in order to create a Twitter account. Once you have

become a follower of @NBCTheVoice, you will receive an announcement Tweet from the @NBCTheVoice Twitter handle on each Entry Start Date as specified in the chart below (the “Announcement”), and you will be required to submit a Retweet of the Announcement with the hashtag #VoiceSweeps” (the "Entry"). You must include #VoiceSweeps" in your Entry or your Entry will not be valid. **If your Twitter profile is set to the “Protect my Tweets” setting, your Entry may be disqualified and rejected as ineligible for consideration in the Sweepstakes. All Entries become the property of Sponsors and will not be acknowledged.

You may enter one (1) time per Entry Period, for a maximum of thirteen (13) Entries during the entire Sweepstakes Period. Multiple Entries received from any person beyond this limit will void all such additional Entries. Entries must be received by the end of each Entry Period to be eligible for the corresponding Entry Period. Sponsors' computer shall be the official timekeeper for all matters related to this Sweepstakes. WINNER SELECTION AND NOTIFICATION: On or about each Drawing Date, one (1) potential Winner, will be selected in a random drawing by representatives of Sponsors from all eligible Entries received during the corresponding Entry Period. DISPUTES: THE SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN NEW YORK, NEW YORK. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
