

The Voice & Kelly Clarkson Concert Sweepstakes

Official Rules

November 19, 2018 - December 11, 2018

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The Voice & Kelly Clarkson Concert Sweepstakes will begin on November 19, 2018 at 3:00 AM PT and end on December 11, 2018 at 11:59 PM PT. All times in the Sweepstakes refer to Pacific Time ("PT"). Odds of winning depend upon the number of eligible Entries received. Sweepstakes is subject to all applicable federal, state and local laws. **PRIZES DO NOT INCLUDE ACCOMMODATIONS, PARKING OR TRANSPORTATION.**

ELIGIBILITY: Open only to permanent, legal United States ("U.S.") residents who are physically residing in one (1) of the forty eight (48) United States or District of Columbia (excluding "Hawaii, Alaska," Puerto Rico, Guam, the U.S. Virgin Islands and other United States territories), and who are eighteen (18) years of age or older and of the age of majority in their state of residence as of the start of the Sweepstakes Period. Officers, directors, and employees of Sweepstakes Entities (as defined below), members of these persons' immediate families (spouses and/or parents, children, and siblings, and each of their respective spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Sweepstakes. Please note that you must agree to comply with the Twitter Terms of Use in order to create a Twitter account. Once you have become a follower of @nbcthevoice, you will receive an announcement Tweet from the @nbcthevoice Twitter handle on or about November 19, 2018 (the "Announcement"), and you will be required to submit a Retweet of the Announcement with the hashtag "#TheVoiceKellySweeps" and the @reply "@nbcthevoice" (the "Entry"). WINNER SELECTION AND NOTIFICATION: On or about December 14, 2018, two (2) potential winners ("Winners") will be selected in a random drawing by representatives of Sponsors from all eligible Entries received during the Sweepstakes Period. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“JAMS RULES”). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY’S FEES

OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
